“Human Rights: Unique Perspectives of an Arab Justice on Israel's Supreme Court”



The Honourable Salim Joubran was the first Arab Justice of the Supreme Court of Israel, a post he held from 2003 until his retirement in 2017. During that 14-year span, Justice Joubran adjudicated thousands of cases, many of which dealt with human rights issues.

Israel's top court is not only the country's highest appeals court, it also sits as the High Court of Justice, to which anyone affected by Israeli state agencies, including Palestinians and foreign nationals, can appeal in real time against any action by the Israeli state.

For his talk, Justice Joubran will discuss his unique ascent to the country's highest court and will analyze several human rights cases he heard during his tenure on the bench and compare them to the manner in which they might have been adjudicated under Canadian law.
