“Justice for Genocide - Reflections on the World Court’s Rohingya Judgment”



Professor Payam Akhavan is a leading scholar, attorney and expert in the field of human rights and international law. He serves as a Member of the Permanent Court of Arbitration at The Hague, is a former UN prosecutor at The Hague, was the 2017 CBC Massey Lecturer and is a best-selling author.

Professor Akhavan’s talk will draw on the legacy of the 1915 Armenian genocide and the Holocaust, to discuss last week’s historic unanimous Judgment of the International Court of Justice against Myanmar in regard to the Rohingya genocide. Professor Akhavan served as counsel for the successful Applicant in this landmark case.
